OFFICIAL RULES (“Official Rules”)**

IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

By entering the Sweepstakes or accepting the Prize, you agree to these Official Rules.

1. Sponsor: Sponsored and administered by Garden of Life LLC, 4200 Northcorp Parkway, Suite 200, Palm Beach Gardens, FL 33410 (“Garden of Life” or “Sponsor”).

2. Overview/How to Enter: As part of the Garden of Life® 2018 Sun Run 5K Challenge, we want to help you meet your fitness goals! All race registrants will be included in a random drawing to be held at the end of the race for a chance to win the Prize. Dates of Promotion: All Sweepstakes entries, regardless of method, must be received by April 28, 2018 at 7:00 am Eastern Time.

No mechanically reproduced entries accepted. The use of any device or software to automate the entry process is prohibited. Sponsor is not responsible for lost, late or misdirected entries or other communications relating to this Sweepstakes. Incorrect, illegible, corrupt, and incomplete entries are void. Sponsor is not responsible for technical, hardware or software malfunctions, typographical or printing errors, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, misdirected, garbled or delayed entries, notices or other communications or other technical problems or human error related to the Sweepstakes or Sweepstakes entries. Multiple entrants are not permitted to share the same email account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email accounts, identities, registrations and logins, or any other methods may void that entrant’s entries and that entrant may be disqualified. Sponsor, in its sole discretion, reserves the right to disqualify any person who tampers with the entry process or the operation of the Sweepstakes, or who otherwise violates these Official Rules. Sponsor shall be the official timekeeper for the Sweepstakes.

3. Eligibility: Open only to legal residents of the state of Florida age 19 (nineteen) or older at the time of entry. Winner will be required to show proof of current insurance and a valid driver’s license at or before time of prize delivery. Sponsor and its respective parents, subsidiaries, sales representatives, advertising and promotion agencies or service providers involved in the Sweepstakes, and each of their respective officers, directors, agents and employees (collectively, the “Promotion Entities”) are ineligible to enter the Sweepstakes or to win the Prize. One Entry per person, regardless of entry method. Identity and eligibility is subject to verification. **Void where prohibited by law.** Subject to all applicable federal, state and local laws. 4. Prize: One (1) 2018 Honda® FIT 5dr HB EX vehicle, approximate retail value \$19,335.00 (nineteen thousand, three hundred and thirty-five dollars) and an award of \$3,000 (three-thousand dollars). Prize is nontransferable, and no substitution, exchange or cash redemption of Prize will be permitted, except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value. Winner is solely responsible for all taxes arising from receipt, acceptance or use of Prize (including sales, income and property tax, if applicable), and for delivery, processing and handling fees, insurance costs, surcharges, registration, title and license fees and all other costs incurred in claiming, registering or using Prize. Winner will be required to complete an IRS Form W-9, which requires disclosure of Winner's social security or other ID number, and an IRS Form 1099 reflecting the value of Prize will be issued to the Winner as required by law.

Prize will include either standard features or such features as Sponsor may determine, in its sole discretion; any additional options or modifications, if available, shall be Winner's responsibility. Color subject to availability. Any vehicle displayed or pictured in promotional materials may not be the actual vehicle awarded; Sponsor in its sole discretion may elect to substitute another vehicle of the same or like model and style in the event of scarcity due to limited production or unavailability for any other reason. Prize must be accepted "as is," and no warranties will be provided by Sponsor.

5. Odds of Winning: Depend on the number of eligible entries received.

6. Winner Selection and Notification: One winner will be selected by random drawing to be conducted by Sponsor at the conclusion of the race. **Winner will be announced at time of drawing and must be present to win.** Winner may be required to show identification and complete an affidavit of eligibility, Form W-9, liability release and, where lawful, a publicity release. Decisions of Sponsor shall be based on its discretion and interpretation of these Official Rules, and are final and binding in all respects. For purposes of awarding the Prize, Sponsor is entitled to rely on information received through the email account that submitted the winning entry. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address used to enter the Sweepstakes will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder. If announced winner is not present at time of winner announcement, or does not claim the Prize at that time, Prize will be forfeited and Sponsor may select another winner from the remaining eligible entries. Prize will be delivered as arranged by Sponsor, and Winner will be required to take delivery from a dealership or facility selected by Sponsor. Subject to manufacturer/distributor/dealer production and delivery schedules, Prize will be made available no later than one hundred and eighty (180) days after the drawing. Failure to accept possession of vehicle within the time specified in the prize notification may result in Prize being forfeited and awarded to an alternative winner. Winner must be present at the dealership or facility for pick up and provide proof of a valid driver's license and legally required automobile insurance covering the vehicle, along with any other documentation required by law, in order to claim the vehicle. Winner is solely responsible for registering and insuring the vehicle and for payment of all associated fees and taxes.

General: Sponsor reserves the right, in its sole discretion, to cancel, terminate or modify this Sweepstakes if fraud, technical failures or any factor beyond Sponsor's reasonable control threatens to impair the administration, integrity, legality, fairness or proper functioning of the Sweepstakes or makes it impracticable to complete. Sponsor reserves the right to cancel the Sweepstakes in the event of race cancellation, termination, or postponement due to weather or other factors.

Limitations of Liability: To the fullest extent permitted by law, by entering the Sweepstakes and/or accepting Prize, each Entrant agrees to release, defend, indemnify and hold harmless the Promotion Entities from and against any and all claims, damages, costs, liabilities, losses or causes of action related in any way to the operation of or such Entrant's participation in the Sweepstakes and any other claims, damages or liabilities, including without limitation any injuries, damages or losses to any person (including death) or property of any kind resulting, in whole or in part, directly or indirectly, from Entrant's acceptance, possession, use or misuse of Prize or participation in the Sweepstakes. If for any reason an Entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another Entry in the Sweepstakes if available.

Disputes: To the fullest extent permitted by law, by entering the Sweepstakes, each Entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or Prize shall be resolved individually, without resort to any form of class action, and exclusively by the state or federal courts located in Florida; (2) under no circumstances will any Entrant be permitted to obtain awards for, and each Entrant hereby waives all rights to claim punitive, incidental, consequential, or any other damages, court costs, or attorney's fees, other than actual out-of-pocket expense not to exceed fifty dollars (\$50.00); and (3) any and all claims, judgments, and awards shall be limited to such actual out-of-pocket costs incurred, including any costs associated with entering the Sweepstakes, not to exceed

fifty dollars (\$50.00). To the fullest extent permitted by law, Entrant expressly waives any right to claim or recover attorney's fees or court costs. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of any Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Florida, without giving effect to any choice of law or conflict of law rules which would cause the application of the laws of any jurisdiction other than the State of Florida.
